El's World Congress in Jomtien in 2001 unanimously declared EDUCATION FOR ALL to be a major concern and challenge. All El affiliates pledged to do everything within their power to achieve the goal of Quality Public Education For All. Rights-based education can promote democracy, reduce poverty, and assist equitable and sustainable development.

Helping achieve the goal of Education For All presents teacher unions with unprecedented challenges. As important stakeholders in education, teacher unions must be fully recognised as social partners bringing expertise and commitment professional to such discussions.

### El's commitment to Education For All is underpinned by the following

## 1 EDUCATION FOR ALL AND DEMOCRACY

El and its affiliates take the view that Education For All can best be achieved in an environment that allows participation by unions and NGOs in shaping national education policies through the use of democratic tools such as consultation and negotiation. The Dakar Framework for Action (April 2000) unequivocally underlines that governments need to consult with civil society and specifically mentions teacher unions.

### 2 EDUCATION FOR ALL AND QUALITY

EI and its affiliates believe that only QUALITY public education will bring progress, democracy and sustainable development. The goals of Education For All require well-trained teachers who are equipped and resourced to deliver quality education. Quality reduces the student dropout rate and enhances job satisfaction for teachers.

# 3 EDUCATION FOR ALL AND PRIVATISATION

El and its affiliates strive for a PUBLIC school system, which guarantees that all children and adolescents can attend school. Privatisation leads to exclusion, particularly of the weakest in society, since they cannot afford to pay school fees.

## 4 EDUCATION FOR ALL AND GENDER

El and its affiliates find it unacceptable that girls and women are not EQUALLY benefiting from the education system the way boys and men do. El is committed to gender equality and calls upon national governments to achieve the goal of gender equity in primary education by the year 2005.

## 5 EDUCATION FOR ALL AND FINANCING

El and its affiliates urge all governments to increase their INVESTMENTS in education. El considers 6% of the GNP as the minimum investment to deliver education of an acceptable standard. The international community should generously add to this commitment. The global future is at stake!
