## Breakout Session 2: Are Inclusive Education Institutions a Real Possibility or a Dream?

**24 July 2011, 09:00-11:00**

**Venue: Meeting Rooms 2.40**

**Concept:** There is a variety of understandings and interpretations to the aims and process of achieving inclusive education in education systems, schools and among teachers unions. The implication of structural inequalities and of other experiences in education institutions such as oppressive social relationships, require some reflection in order to promote inclusive schools. The session will share knowledge and experiences of the organization of schools, curricular contents, language of instructions, teaching methods, teacher training, as well as attitudes, expectations and actions taken by teachers, school communities and representative organizations to promote inclusive education, and describe the successes and the barriers encountered. The session will also seek to evaluate the successes and failures of positive education diversity policies which have been used to target underachievement and inequality in different groups.

**Concept:** Education and life-long learning are the key to securing the future of individuals and society. Schools should therefore engage with communities. ## Breakout Session 7: Building Effective Partnerships for Quality Education

**24 July 2011, 11:30-13:30**

**Venue: Meeting Rooms 1.40**

**Concept:** There is broad recognition of the fact that the current context of economic crisis constitutes a major threat to the education sector. Budgetary cuts and other measures adopted by national governments not only hinder progress towards Education for All but erode the achievements made thus far. Furthermore, the reduced availability of foreign aid for education puts various programmes and initiatives at risk. This scenario therefore calls for concerted action. As education sector unions consolidate and strengthen existing networks and campaigns, the opportunity arises to establish more and better partnerships to promote investment in education as a strategic response to the current crisis. By working together at the national, regional and international level, EI members can play a leading role in reinforcing the impact of the trade union movement. In order to have an impact on policy decisions at the global level, we should aim to empower unions through independent and critical research combining evidence from the perspective of teachers with best academic studies. Building effective partnerships, however, is not an easy task. This session will provide participants with an opportunity to exchange experiences and lessons learnt and highlight key issues with a view to strengthening the visibility of EI members and making better use of the opportunities and partnerships available.
